The Morrisville Borough Council met on Tuesday, November 21, 2023 at 7:00 p.m. in Council Chambers at the Morrisville Municipal Building, 35 Union Street, Morrisville, PA for a Regular Council Meeting.

1. Pledge of Allegiance

All those in attendance stood and recited the Pledge of Allegiance.

Mr. Paul stated before we commence a roll call of the Council I also want to point out that there's going to be a change in the order in which we address the agenda specifically the Mayoral candidates instead of speaking near the beginning after the Winterfest presentation I'm moving that down until after the presentation of the committee reports that way the Mayoral candidates will be able to speak right before Council votes on them so it'll be fresh in our minds. Some of our memories are not what they used to be so I want to put those next to each other timewise.

Public Comments

1. Israel Valez – 622 Barclay Avenue

He stated that he is a renter who is retired from Human Services in New Jersey and he came back to his hometown to retire. He stated that he ran into a discrepancy with the place that he is renting and has to leave due to a certain document that he feels was falsified which got him into his rental unit and now he has 10 days to find a new place to live. He is asking Council to look into the situation further regarding the falsified U&O document that he has that has led him to his current situation. He would like it investigated. He stated that his wife is sick and the situation has exacerbated her condition and he feels it has merit. He feels he is not alone and that it will help out other renters who are possibly dealing with the same situation.

There being no further public comment, the President proceeded to the business portion of the agenda.

6B. **Approval of the Bill List**

Motion to approve the bill list and pay the bills.

Motion made by Ms. Price Engelhard and seconded by Mr. Lubin.

No discussion took place regarding the motion.

Motion carried by voice vote 7-1. (Nay vote being Mrs. Sherlock)

Mrs. Sherlock stated, for the public's knowledge the total bills for this month are \$492,751.00, a lot of that was the towpath project that you see and it includes some of the money for the sewer, the roof, architect and the electric panel which are the improvements that we are doing that are all positive.

7. Reports

Mayor's Report 7A.

Mr. Paul reported that as the acting Mayor he has no report tonight. He stated we've got a lot going on and most of my time has been spent getting things ready for the next Mayor which will be the next item of business. He stated that we don't have a Police Chief currently but

we have Corporal Bill Smith who is the officer in charge of the department right now and I've asked him to come to give us a status report on the police department.

7B. Police Chief's Report

Corporal Bill Smith reported that yesterday he submitted the monthly reports to the Manager for distribution to the Council members the numbers are fairly consistent with the previous months we've had really no difference in crime. Halloween night was a success there were a few disturbances during the trick-or-treat hours we had additional three officers in marked police vehicles and the Police Chief on a bike. I believe that one of the keys to reducing the problems during Halloween night was the fact that years ago we instituted the trick-or-treat curfew which drastically reduced the number of people being outside after 8:00, 9:00 at night. Moving on to motor carrier enforcement, Officer Halas has 10 more mentored inspections that he is currently doing with the Sergeant in Falls Township the inspections should be completed by the second week of December. Once he is certified I will assign him to inspection details when manpower allows but I can assure you that the program will be successful. As the holidays approach I'd like to remind everyone to lock their cars especially if you're leaving items in there after shopping. If there's any suspicious activity I urge everyone to call the police immediately it's important that these things are reported to us as they are occurring it's easier to apprehend someone when they're actually committing the crime versus when we're trying to review video to identify them. The last note that I have is that the police department is stable, it's running efficiently even after the departure of Chief of Police. My philosophy at this point is to continue operating business on the business as usual philosophy. All the officers who are scheduled and working have continued to do their jobs with no issues and that's all I have. Thank you.

7C. Manager's Report

Manager Danko stated it's very nice to see the room filled with people. On my managers list this evening we do have the Bridge Street project that we've talked about for a long time we're coming to a final closing of that project in December. Originally the final inspection was scheduled for December 4th we're still waiting for some railings so that may move to December 14th, they'll certainly inform Council and everyone as soon as we hear that but it's due to the railing delay but we're happy to see the progress that has been made anybody that goes in that area you can see really what the full potential of the trail will be leading to that area. The other item that I wanted to discuss I had on my last manger's report some misinformation about the Clover Leaf property so please accept this as a clarification of misinformation that I was provided. The RDA and the Clover Leaf property the RDA has not started on the implementation of the cleanup plan date the RDA is working through the permitting currently and also Bob White has no role with the RDA I believe he may be in consultant for the redeveloper. I just wanted to let everybody know that was a misstatement that was on my report because I was provided with incorrect information. We did have a kickoff meeting last week with Snyder and Hoffman Associated regarding the electrical panel work that's going to be taking place we're very excited about that. The roof is about 90% complete at this time thanks to John Later he noticed there was an issue with the flashing and I contacted the contractor and we're getting that fixed as soon as possible. other items that we have is we have been working on a policy and ordinance committee we've been working on reviewing noise ordinance and alarm ordinance so anyone that sees that information listed on the website and you're interested in coming to the meetings please do so. The blight procedures that took place at 327 Prospect Avenue there's been some questions as to what's going on with the property at this time the property is sold and the developer is correcting all of the issues at the property and going to clean the property up and of course resell that property and that's all I have at this time Council President.

7D. Committee Reports

Parks and Recreation

Ms. Price Engelhard reported that due to the budget meeting there won't be a November meeting. She stated that at the last meeting they did a recap of what they've done this past year and between cleanups and tree planting and cleaning up the benches and painting the tables and benches, painting the pool shack house we kind of felt like we'd really done quite a bit, plus the Preserve so were very proud of that. Last weekend we planted eight trees just to be clear the money was donated anonymously so nothing came out of the Borough coffers. We had nearly 30 volunteers come out last Saturday and it was very well organized thank you Gary and Debby and the rest of you did a really nice job I was part of it I think mostly I just picked up rocks but then Jason would give me more rocks

Mr. Manness stated, to be fair they were pretty cool rocks.

Ms. Price Engelhard stated, they were pretty good rocks and it was very well organized, a fun day, there are several people in the audience that participated and thank you so much it looks really nice, I can see that those trees in a couple of years it's just going to be beautiful, it's going to be stunning, so thank you. We also talked about the Girl Scouts and their bench program and so the Council accepted that and so save your plastic grocery bags because we're going to make them into benches there's more to it than that but save your shopping bags. You can take them to Twisted Root on Bridge Street then they get mushed and put together and make benches. We did the cutting of the cherry tree with George Washington so that was great. We also had Bucks County TMA which you see we're going to approve being a membership of and they've already located a place and we've kind of set a date for next spring, I'll take it to Council and have it voted on but to do a popup bike trail. This is going all over the state of Pennsylvania they're temporary we do it for four days and they do all the work and it costs us nothing but we also do a lot of safety education and stuff that day with kids and people and everyone involved. Thank you so much.

• Finance Committee

Mr. Lubin stated this is budget season as many of us know we've had quite a few of our residents attending our meetings. Our next meeting is going to be Wednesday night 7 p.m. here. Here is the budget in a nutshell we are now a \$6.2 million Borough I believe the highest budget the Borough has ever had we are solvent so things have changed between ARPA money and the EIT we are using the money carefully conservatively. We are putting

money in a reserve fund because for example the tax revenues between November, December and May and June are very slow but this is how we pay bills the tax money comes in then the fund that fund gets reimbursed gets repaid. We have money for the major infrastructure problems that we've had at Borough Hall between the ARPA money and some EIT. The roof is being fixed, sewage pipes downstairs and outside have been fixed, our electrical box is in the process of being repaired, and we have a new Gasboy. Many small projects are being address and all the committees and all the things that were cut last year are being restored to last year's levels or as close as possible. It's going to be a conservative budget we're going to keep it that way but again the next meeting is Wednesday night 7 p.m. here you're all welcome to attend.

• Community Choice Aggregation

Mr. Manness reported over the course of the last several months the Community Choice Aggregation Exploratory Committee; we've been tasked with validating the claims of CCA for PA to see if that is right for this Borough to join in with Community Choice Aggregation. A brief thing it's basically like much like a union, collective bargaining can lead to more specific outcomes their claims where that cost savings to the average consumer are possible and again I will have a more comprehensive formal report for the December meeting but overall I'm feeling very positive that we were able to validate a lot of the claims that CCPA made and I'm looking forward to more clearly expressing that. I apologize that is currently what I have thanks.

• Morrisville Business Association

Ms. Hlahol reported that mine is actually a request, the MBA and actually goes out to all residents as well as the MBA will be putting up the Christmas decorations up at the plaza right after Thanksgiving. They have been tasked with decorating the Robert Morris Plaza so November 27th through 29th is when the anticipation is last year Jane and I we spent a lot of time and we got a lot of free ornaments and we have a 12 foot Christmas tree that we got so Judith is there a way that public works could help put down that 12 foot tree, last year it kind of got blown in the wind and we need a little bit of help.

Mrs. Danko stated, yes I had spoken with Jane and John Later and we're already engaged in making sure that happens.

Ms. Hlahol stated, okay great so we actually got a lot of donations from some businesses Big Lots gave us a blow up snowman, Hope Depot was very generous for only \$20 we have a Santa Claus in a motorcycle, so I'm looking actually forward to seeing what it turns out to look like. The other thing that happened was Toll Brothers was here last month and they were talking about putting up right outside of Green Street a Do Not Block Box so I've been talking to Toll Brothers and I also gave a call to the Bridge Commission in order to try to figure out how to do that without giving an expense to the Borough so in talking with the Bridge Commission they had mentioned that they're going to start doing a study to see that whole area of where the ramps are and they asked me some questions like what would we like to see there so one of the things one of the officers told me was to put flashing stops

instead of just a stop. I gave them a little bit of a list of what Morrisville would like to see but hopefully they can rearrange that whole area. I did ask them if we could put up signs on their ramp saying please continue on to Route 13 for the trucks but they didn't answer me on that but I'm definitely going to keep working on that so that's all I have. Thank you.

Mr. Lubin stated, speaking of December 2nd and the Morrisville Business Association the MBA and British Cars of Bucks County falling on Donna's December 2nd Winterfest event we're doing a Toys for Tots toy collection over at Morrisville Shopping Center between 10:00 in the morning and 3:00 in the afternoon. We're looking for donations of new and unwrapped toys and books for boys and girls. We'll have a few Marines from the local Toys for Tots Reserve Group appearing. We've got some of the politicians from Doylestown our VIPs are Bob Harvey and Diane Marseglia, Brian Fitzpatrick has promised he's going to show up but what we really need is not publicity we need donations of toys so whatever you can bring in. Judith, we're going to put a drop box downstairs, we discussed that yesterday?

Mrs. Danko stated the drop box has been there for about a week.

Mr. Lubin stated, super thank you very much. I'd like to say I'm tied up on budgets but not entirely. Bring them on that Saturday, bring them down to Borough Hall and finish our event.

7E. Mayoral candidates public speaking opportunity. Jackie Bergevin, George Dodig, Diane Lanahan, Shawn Ratti, Benjamin Louis Strauss, Gary Wallace and Tom Wisnosky.

Jackie Bergevin — She stated, I am not prepared to say anything. I don't know what to say honestly. The issues facing Morrisville right now are way more important than any football game public safety, and public well-being the number one job of ay local government. Now I mean no disrespect to our police officers and Corporal Smith who have a very difficult job I have nothing but admiration for our police force they are my heroes they really are but our department is in crisis we're without ahead coach, we're without a Mayor, we're without a Chief of Police, we're trying to steer a ship that doesn't have a rudder we need leadership, we need direction and we need it right now. So it's important that our new Mayor hits the ground running that he has the experience to show up tomorrow morning and get to work. I agree completely with the idea that new faces are good in borough government, in fact I didn't run for a third term because I believe in term limits I believe in government turnover and there's a lot of great new faces here interested in being Mayor I think that's wonderful but now is not the time for that but here's a question for you we just had the municipal election and in the third ward where I live we only had one person on the ballot even in the primary thank goodness it was a good one appreciate that but some of the applicants here tonight are from the third ward, where was the interest then, where were they, where was the desire to make positive change then, why all of a sudden now? For we all know that if one really wants to make a difference Council is where you need to be not the job of Mayor, because the Borough Code gives all the power to the Council not the Mayor. Now there are two members of Council that were appointed to fill unexpired terms thank you for stepping up and doing your civic duty really do appreciate that. One of the things that you have learned is that it takes a while to learn to be a Councilperson it's not intuitive and I will tell you from personal experience that it takes a year to learn to be the Mayor because the job is not defined in the Borough Code so the million dollar question roll the dice with public safety to train a new Mayor or go with someone with the experience. Thank you very much for your most kind consideration.

Mr. Paul stated, thank you to all of you for your presentations, very inspiring. I just want to say before we move on to the action items I encourage all of you all seven of you to stay involved, please stay active. As Mr. Wisnosky pointed out we need a lot more candidates for Council that's really where a lot of the hard work is done. It's embarrassing that we have seats that go vacant with nobody running or only one person running unopposed and I encourage all of you to tell your neighbors and friends to please volunteer we have lots of things going on. Mr. Wallace has already been very active in the short time he's been in town.
